This training session will cover the many aspects of identifying and dealing with sexual assault in the prison environment, using interactive exercises, survivor accounts, and discussion. The group will work on developing a multifaceted approach that recognizes corrections' concerns, mental health needs of survivors, the role of community rape crisis program, and barriers to reporting sexual violence in detention. This collaborative approach honors multiple goals and perspectives and yields the best outcomes for survivors, corrections, and the community.
